#### Life +


In spite of a positive hope to have the Life+ program being accepted after a second attempt, the collaborative project "Proagrirecycling" has not been accepted by the commission.

#### CICLOAGRO – Spain

CICLOAGRO General Assembly (14<sup>th</sup> Feb 2017) and Board Meeting (28<sup>th</sup> March 2017)

#### I. Activity report 2016, Cicloagro in Andalucía

39 700 tons recycled, 100% collected being recycled, 80.5% collecting rate. 59% greenhouses, 38% mulching. Increase in recycling since 2013





- Volume declared: 46157t equal 49326 t of used material.

## **II. Statistics**

- National volume reported APE Europe, new product: 91KT national.
- National volume reported by Cicloplast new product: 102 Kt national.
- Difficult to establish specifics statistics only for Andalousia because converters and distributors sell on a nationwide scale
- Necessity of a further analysis, eventually based on surfaces.

## III. Assessment in current situation.

Legal Frame: Law 73/2012 only for Andalousia, mandatory for agri-plastics raw material producers and converters. New legal situation: article establishing collecting and recycling objectives has been repealed.

High technology recyclers for mulching and greenhouse plastic (4 recyclers). High value in market for greenhouse used plastic (150-200  $\notin$ /t) but negative or neutral value for mulching (-5 ...0  $\notin$ /t). This frame allows the schema working and collecting increasing quantities, but in some cases it is difficult to keep the balance.

Some Difficulties encountered:

- 1) Occasionally situation with marine litter + plastics left on the field.
- 2) Number of collecting sites insufficient (agricultural cooperatives don't want colleting points on its site).
- 3) Small volume disseminated and difficult to group and collect (ex. mulching Motril 500 t).
- 4) Volume treated out of Cicloagro scheme (greenhouse used film because of its great value).
- 5) Unstable balance in mulching recyclers, depending on the sale price of plastic pellets

## **IV. Conclusion and main Agreements**

- Cicloagro will promote agreements with recovering companies, not only with recyclers for improving the network, (new collection points).
- Cicloagro will go on in operation with the same scheme as it is implemented only in Andalousia. The system shouldn't create distortions in the national market so products can't have different taxes in different autonomic regions.
- Cicloagro will explore new schemas (Sigfito, French schema) without any engagement for its implementation.
- Gather information about systems to reduce plastic contamination on-site (farm property) in order to reduce contamination rate.

## **APE Comments**

The Cicloagro scheme has performed rather well and has allowed to increase drastically the level of knowledge about products, wastes, collecting recovering and recycling.

However, it will be valuable orient Cicloplast activities in several directions:

- A deep analysis on mulching, the collecting being under threat and may disappear.
- To consider the extension of Cicloagro nationwide
- To reconsider the financing of Cicloagro allowing the possibility to run R&D project and save the mulching scheme.



## APE UK

Due to different events on the market and the lack of consent on the proposed scheme, it has been agreed to put the UK scheme implementation in stand-by.

All attendees agrees that APE Europe will take an initiative on the matter, as soon as ERDE is on track.

### CIPA

An important networking work has been made in order to facilitate subscription for Plasticulture and the preparation of the CIPA Congress.

The CPA took over Spain the management of CIPA (International Committee of Plastics in Agriculture), the magazine 'Plasticulture' and the organization of the next CIPA Congress in 2018.

- The CIPA act internationally under the same frame of national committee and APE Europe.
- Plasticulture (French, English and Spanish...) is a tool for the plasticulture community, increase and disseminate knowledge around plastics in agriculture.
  BLM launch an appeal to all the plasticulture community and 'plasticultors'. They must appropriate themselves its tool and contribute to it in articles, advertising and sponsoring. The next publishing, expected in June or September, is focused on biodegradable products for agriculture.
- The next CIPA Congress is organized in Bordeaux-Arcachon on May 29<sup>th</sup>, 30the and 31<sup>st</sup>, 2018. Situated south-west of France, on the Atlantic Ocean, Arcachon is a resort place and a fishing port. Bounded on the North by famous Bay of Arcachon and on the South by the astonishing Pilat's sand dune, Arcachon, next to the largest artificial forest in Europe, is also located at the middle of an important area of agriculture production: asparagus, carrots, green beans, kiwis, maize and the well-known worldwide Bordeaux vineyards. The Congress Palace is located on seaside, on the beach, with a large choice of hotel and restaurant at footsteps.

Once again the support to this event of the plasticulture community is most welcome.

## "Operation Zero agri-plastics waste in nature"

The paper position on "zero waste in the ocean" become "Zero agri-plastics waste in nature" has been made on hold.

## Biodegradable

A technical note is under preparation on biodegradable for agriculture in France. The objective is to educate on the reality of biodegradable product for agriculture. The final version will be proposed to APE Europe.
